

**FANDANGO'S MISSION MONDAY PREMIERE SWEEPSTAKES** ("Sweepstakes")  
OFFICIAL RULES ("Official Rules")

**NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants ("Participants") agree to be bound by these Official Rules and the decisions of Fandango Media, LLC ("Sponsor"), which are binding and final on matters relating to this Sweepstakes.

Sweepstakes Entries generated by script, macro or other automated means, and Sweepstakes Entries by any means which subvert the entry process, are void. **SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION:** Winner is subject to verification of eligibility requirements, including verification of age. The potential winner of the Grand Prize (defined below) is referred to herein as the “Winner”.

Sponsor is not responsible for any cancellations, delays, diversions, or substitutions, or any act or omission whatsoever with respect to any Grand Prize.

Odds of winning will depend on the number of qualified Sweepstakes Entries received during the Sweepstakes Period.

**GRAND PRIZE (1):** There is one grand prize ("Grand Prize") available to be awarded to one (1) Winner. Winner will receive a three (3) day, two (2) night trip for Winner and one (1) guest ("Guest") to the *Mission: Impossible – The Final Reckoning* premiere in New York, NY. Date and/or time of the Event is subject to change. Event is subject to cancellation. **CHOICE OF LAW AND JURISDICTION:** All federal, state, and local laws and regulations apply. Void where prohibited by law. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any Participant and the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the state of California without giving effect to any choice of law or conflict of laws rules (whether of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than California. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules not subject to arbitration shall be brought only in the courts of the State of California, in the County of Los Angeles. You hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non-conveniens or lack of personal jurisdiction.
